



SolaTrim's 10 Year Limited Warranty

SolaTrim LLC manufactures a Solar Pest Barrier and warrants the material will not separate off the solar panels when installed correctly and will not have paint peels due to normal weather conditions. SolaTrim is fabricated from stamped, primed & painted aluminum. SolaTrim reserves the right to change this warranty at any time, but all warranties in effect at the time of installation will not be affected by any changes and will remain in effect until their expiration.

SolaTrim's 10-year Product Warranty

SolaTrim LLC warrants a 10-year transferrable warranty from the original date of installation by any authorized installer. This warranty covers only genuine SolaTrim products installed.

SolaTrim's 10-year Performance Warranty

SolaTrim LLC warrants that the SolaTrim barrier will not separate from the solar panel frame during normal conditions when installed correctly by any authorized installer. This warranty covers only the replacement of the SolaTrim products per terms listed below. This warranty is limited to the terms and conditions, exclusions and limitations, requirements and legal rights stated in this warranty and when installed in accordance with the SolaTrim ST-450, ST-550 and ST-675 product specifications.

SolaTrim's Warranty Terms

SolaTrim LLC will replace the needed SolaTrim product free of charge, and cover shipping costs of needed SolaTrim products, free of charge, within the 10-year warranty timeline. The Warranty does not cover labor or cost associated with removal, repairs and-or installation or other misc. expenses related to the warranty issue.

Conditions

We reserve the right to discontinue or change any design or color of any of our Products at any time without notice or liability. If, for any reason, the SolaTrim type originally installed is no longer available from us at the time you make a warranty claim, we may substitute another product determined by us to be of comparable quality and price.

There are no warranties on SolaTrim products other than as set forth in this warranty. We are not liable to you for a breach of any other written or oral express warranties, such as those, if any, given to you by installers, dealers, contractors, applicators, or distributors of SolaTrim products. Effective December 12, 2019.

Due to normal weathering, replacement Product may differ in gloss or color from the Product originally installed. We exclude and are not responsible for any consequential or incidental damages arising out of any breach of this expressed warranty, or any other oral, written, or implied warranty that may apply to your purchase, as it relates to SolaTrim. This is your exclusive warranty and is in lieu of all other warranties, express or implied, including but not limited to implied warranties of merchantability and fitness for a particular purpose.

This warranty gives you specific legal rights. You may also have other rights which vary from state to state. Some states do not allow the exclusion or limitation of incidental or consequential damages, and some states do not allow limitations on how long an implied warranty lasts, so the above limitation or exclusion may not apply to you. The obligation under this warranty will in no event exceed the purchase price of the originally installed Product found to be defective. In the event that we choose to replace SolaTrim, we will only be responsible for providing material and not the cost of labor to install or shipping costs.

SolaTrim ST450, ST550 and ST675 are the best performing solar pest barrier on the market today. In most cases, rainfall alone is sufficient to keep it clean, but there may be some instances where cleaning/maintenance will be required by the homeowner. Light winds should remove most side debris, but if debris is wet or compressed, higher winds may be required to effect side debris removal or homeowner physically removing side debris. We recommend occasional homeowner cleaning and maintenance inspection of the entire solar panel.
